- When traveling or at an event: Personal cell texting or calling is likely needed and should be expected from those traveling. All other times, please Slack a message asking for consent to call.






## **Project Management**




## Communication




## File Storage

 Microsoft Word, Excel, PowerPoint, Outlook, and Teams








#### SQUARESPACE




